**Hotel Policies to be Aware of:**

**Additional Fees** – In addition to the room rate, there is a resort fee of \$5.00/day. Total applicable taxes are 12.55% and consist of: 10% Occupancy Tax, 1% CTID Assessment, 1% Environmental Protection Fee, plus 0.55% CA Tourism Assessment Fee per occupied room night.

**No Smoking** – There is no smoking inside the hotel. Smoking is permitted in designated outdoor areas only.

**Transportation** – The hotel does not offer shuttle service to/from the airport. They do, however, offer a shuttle service via golf-cart to the Silver Strand State Beach and to Downtown Coronado Village via a 12 passenger van. Both are included in the resort fee.

**Parking** – Valet parking is available on the property for \$35.00 per day maximum, with in and out privileges. Self parking is available for \$21.00 per day maximum, with in and out privileges. \*Rates are subject to change.

**Attire** – Resort casual is recommended.
