Hotel Policies to be Aware of:

Resort Fee – There will be a resort fee of \$19.99 per room, per night, plus state and local tax that will cover basic guestroom WIFI, self-parking, shuttle service up to a two mile radius outside of the resort, 1 hour of Tennis or Pickleball court time per day, Splash Waterpark, Fitness Center and in-door pool access, Children’s activities, local and toll free calls.
